Southport Sharks Group Booking Policy

To secure your booking, please complete the booking confirmation form, providing signed credit card authorisation. Seating Requests/Dining options

We will do our best to seat your group in your preferred area; however we are unable to guarantee this due to the changing nature of the restaurant and entertainment area. We prefer groups of 16 or more to come into the venue to meet with our restaurant manager so you can view your seating options

Group bookings are required to dine from our buffet only, as A la carte is not available for group bookings. All guests booked are required to order a buffet or may be asked to vacate the table for other diners.

Booking periods are strictly for:

- 5:30pm/6pm to vacate the table by 7:30pm; or
- 8:00pm where you may remain on the table for the remainder of the evening

Deposits/Accounts

For Groups of 16 or more a \$200.00 holding deposit is required to confirm your booking.

- Deposit will be held as security for the booking, with the deposit being deducted from the total bill
- Final numbers must be confirmed by 5pm on the day prior to your reservation. The person making the booking is required to contact the restaurant to confirm the numbers
- The deposit will be refunded if the booking is cancelled within 48 hours of the reservation
- All accounts must be settled in full on the date of the reservation
- Pre-payment for the group is encouraged and we can accommodate that to make your evening easier.

***All group bookings of 15 or more that pre-pay for their entire reservation receive a voucher to the value of \$50.00 to be redeemed in the lounge bar
(Voucher only redeemable in one transaction on the day of the booking)***
